CALL FOR EXPRESSION OF INTEREST

BACKGROUND

The Ministry for the Environment, Land and Sea of the Republic of Italy and the former Ministry of Environmental Protection and Physical Planning of Montenegro signed in November 2004 a Memorandum of Understanding (MoU) on "Cooperation for Environmental Protection", in order to maintain and enhance bilateral cooperation in the field of environment and sustainable development on the basis of equality, reciprocity and mutual benefit.

The successful cooperation between the two mentioned Ministries has been also established in the field of the CDM implementation resulting in an efficient contribution to sustainable development focusing on the assessment and development of the GHG emission reduction projects.

In the scope of this bilateral cooperation, the Ministry for the Environment, Land and Sea of the Republic of Italy and the Ministry of Sustainable Development and Tourism of Montenegro (a successor of the above mentioned Montenegrin Ministry) have jointly identified the North-Eastern part of Montenegro (Berane, Andrijevica, Rozaje, Plav and Bijelo Polje) as suitable area for Wood Biomass to energy plant pilot project.

Within this framework, a feasibility study was realized, proving the technical and economic feasibility for plant construction, operation and maintenance at the Berane site. A summary of the study, prepared by the CETMA Consortium under the supervision of the Steering Committee, is attached to the present Call (Attachment I).

Therefore, the Steering Committee, established according to the Annex II to the Memorandum of Understanding between the Italian Ministry for the Environment, Land and Sea and the Ministry of Sustainable Development and Tourism of Montenegro, is now issuing a Call for Expression of Interest to select the most competitive company wishing to establish a partnership with the local site owner (Berane Municipality) in order to implement the aforementioned project, providing for that purpose a co-financing allocation of $30.000 \in$.

OBJECTIVE OF THE CALL

The present Call for Expression of Interest aims at selecting an Italian or Italo-Montenegrin company willing to implement the project "Berane Wood Biomass to Energy Plant". The project is to be realized at the old paper factory location, in the North-East of Berane urban area, in association with the Berane Municipal Government (site owner).

As the first step in carrying out the project, within 6 months from the date of selection the selected company shall present to the local site owner a detailed proposal on the technical and commercial conditions for the project implementation.

As the project is to be developed together with the site owner, the second step of the project realization would entail the creation of a partnership with the Berane Municipality (local site owner).

PROCEDURE

The Call for Expression of Interest will be conducted pursuant to the procedure and the criteria set by the Steering Committee established according to the Annex II to the Memorandum of Understanding between the Italian Ministry for the Environment, Land and Sea and the Ministry of Sustainable Development and Tourism of Montenegro.

Being realized within the framework of a bilateral cooperation agreement between Italy and Montenegro, signed on November 11th, 2004, the present Call is issued in accordance with the Article 3, paragraph 1, point 2a, of the Law on Public Procurement of Montenegro (OJ 46/2006):

- applicants are invited to express their interest in implementing the project, while giving sufficient evidence of their technical and professional capacity and financial / economic solidity;
- a technical commission, which will include experts from the Italian Ministry for the Environment, Land and Sea, the Ministry of Sustainable Development and Tourism of Montenegro, Berane Municipality and the CETMA Consortium, shall review the applications received and select the company that best fulfill the conditions set below;
- in order to assist the selected company to produce high quality technical documentation for the realization of the project, the full feasibility study will be made available to the selected company, upon the signature of a confidentiality agreement;
- in 6 months time from the selection, the selected company shall present to the local site owner a detailed proposal on the technical and commercial conditions. Technical documentation, which shall include the Conceptual Project as described in the Law on Spatial Development and Construction of Structures (OJ 51/08, article 79) and its modifications (OJ 40/10), shall be in compliance with the relevant Montenegrin legislation¹ allowing for obtaining all permits and licenses from the local authorities necessary for project realization;
- the conceptual project shall determine at least:
 - position (micro-location),
 - capacity, technical, technological and functional characteristics of the system,
 - technical-technological and organizational elements for the construction and the maintenance,
 - indicative calculation of stability and safety of the structures,
 - design of infrastructure
 - preliminary environmental impact assessment;
- the project implementation is subject to approval of the aforementioned proposal submitted by the interested company which will be evaluated by a technical commission composed of experts from the Italian Ministry for the Environment, Land and Sea, the Ministry of Sustainable Development and Tourism of Montenegro, Berane Municipality and the CETMA Consortium;
- once the best proposal will be selected, an agreement shall be signed between the selected company and Berane Municipality, defining the common implementation of the project and the form of the partnership.

DOCUMENTS REQUIRED FOR THE EXPRESSION OF INTEREST

Applicants are required to submit the complete documentation listed below in English language (with the exception of official documents, such as certifications and financial statements, which can be enclosed in the language of origin).

In case an incomplete application is submitted, the Steering Committee reserves the right to reject the Expression of Interest.

The Applicants need to submit the following items:

- a) Cover letter (Attachment II);
- b) General information (Attachment III);
- c) Proof of legal existence recent extract from Italian Professional or Trade Register, or equivalent document (Attachment IV);
- d) Declaration on exclusion criteria (Attachment V);

- e) Proof of financial capacity (year-end balance sheets and profit and loss accounts for the past 3 financial years), with summary table for selected indicators over the past 3 years (Attachment VI);
- f) Reference list of key projects carried out by the Applicant (Attachment VII), with specific reference to the construction and operation of biomass power plants;
- g) Resumes (EC format) of the project team members, with summary table (Attachment VIII).

The Commission may request the Applicants to provide clarifications and/or additional information on the documentation submitted.

SUBMISSION OF THE EXPRESSION OF INTEREST

The deadline for the presentation of the Expressions of Interest is 45 days from the day of publishing of this Call.

Any Expression of Interest received after the deadline shall not be considered.

Each Applicant shall be informed in writing of the outcome of the selection process within 45 days from the expiration of the deadline for the submission.

SELECTION CRITERIA

Applicants shall be assessed based on the following set of criteria:

1. Proof of Registration

The applicants must prove their enrolment in a professional or trade register in the Republic of Italy. The relevant professional and trade registers in Italy are the "Registro della Camera di Commercio, Industria, Agricoltura e Artigianato", the "Registro delle Commissioni Provinciali per l'Artigianato" or the "Consiglio Nazionale degli Ordini Professionali". Recent extracts from such registers should therefore be submitted.

Applicants failing to do so shall be automatically excluded from participation.

2. Technical and Professional Capacity

The Applicant should possess the technical and professional capacity to realize the project. The technical capacity of the Applicant will be assessed by using indicators such as:

- Key expertise/core business of the Applicant, years of operation, permanent technical staff;
- Previous experience of the Applicant in similar projects, with specific reference to the construction and operation of biomass power plants;
- Professional experience of the Applicant in the Balkan countries;
- Strength of proposed project team (training, professional qualifications, regional experience, years in the business).

3. Financial and Economic Standing

The financial and economic standing of the Applicant will be assessed based on, amongst others, the following indicators:

- Net equity;
- Net assets;
- Total sales;
- Gross profit.

4. Ineligibility

Any applicant shall automatically be excluded from participation if:

- Is bankrupt or is being wound up, whose affairs are being administered by the court, who has entered into an arrangement with creditors, who has suspended business activities or who is an analogous situation arising from similar procedure under national laws and regulations;
- Is the subject of proceeding for a declaration of bankruptcy, for an order for compulsory winding up or administration by the court or for an arrangement with creditors or of any other similar under national laws and regulations;
- Has been convicted of an offence concerning his professional conduct by a judgment which has the force of res judicata;
- Has been guilty of grave professional misconduct proven any means which the contracting authority can justify;
- Has not fulfilled obligations related to the payment of social security contributions in accordance with the Italian legislation;
- Is guilty of serious misrepresentation in supplying or failing to supply the information that may be required under this Call for Expression of Interest.

ATTACHMENT I

GENERAL DATA

The Municipality of Berane is located in the North-Eastern part of Montenegro. The city of Berane is located at 42° 50' 52" North, 19° 52' 32" East and 700 m above sea level (a.s.l.). The area for the power plant is approximately $2,000 - 3,000 \text{ m}^2$ and it is located in an area occupied by a dismissed paper factory. This preliminary plant layout includes:

- wood biomass handling;
- thermal oil boiler;
- combustion gases treatment plant;
- ORC module;
- cooling water system.

The medium voltage line available is a 35 kV line at a distance of approximately 1.5 km.

BIOMASS PRODUCTION, ELECTRICITY GENERATION AND ESTIMATION OF GHG EMISSIONS REDUCTION

Based on the wood chain analysis developed in the feasibility study the following data were used for the power plant sizing:

- wood residues usable for the power plant were estimated equal to 37,000 m³/y;
- wood residues average density was assumed equal to 550 kg/m³;
- wood residues average low heating value was assumed equal to 3 kWh/kg (2,580 kcal/kg); this value is referred to a higher humidity content (approximately 35-40%).

The installed electric power is estimated in around 1.32 MWe. It should be pointed out that there are large amounts of residues abandoned in many sawmills and that the amount of residues recovered in sawmills will increase in the future and they can be used to produce pellet or, in case of a large amount of residues, to install a new electric generation line for a further electricity production.

Being the subject project eligible as Clean Development Mechanism (CDM) project, its contribution to the GHGs emission reduction plays a key role in improving the revenues of plant operation: according to the official UNFCCC ACM0006 Methodology the emissions reduction deriving from the plant operation was estimated in approximately 15,650 t CO_{2eq} /year.

PRELIMINARY FINANCIAL ANALYSIS

The foreseen capital expenditure (CAPEX) for the project realization is approximately $5,105,000 \in$. The yearly Operation and Maintenance (O&M) costs were estimated equal to $44,000 \notin$ /y. The financial analysis considers the possible revenues originating from one or more of the following sources:

- sale of the electric energy generated by the plant and delivered into the National Power Grid;
- sale of Certified Emission Reductions (CERs) produced by the implementation of the Project within the Kyoto Protocol's flexible mechanisms (CDM).

The impact of CERs upon financial performance was evaluated assuming a CERs price equal to $10 \notin t$ CO2eq over the emission crediting period. The UNFCCC regulations foresee the opportunity of obtaining CERs either for 10 years or for 21 years. The assumed duration of CDM for this project was of 10 years.
